For **refundable fares**, Delta allows full refunds if you cancel prior to departure +1-888-738-0798 These tickets are the most flexible, and cancellation will result in the unused portion being refunded to your original form of payment +1-888-738-0798 You typically initiate this process via the “My Trips” section on Delta’s website or app and choose “Need to Cancel” +1-888-738-0798 Once processed, you can monitor the refund status online +1-888-738-0798 Refunds to credit/debit cards generally take about 7 business days, though the bank or card issuer may delay the posting +1-888-738-0798 For tickets paid in cash or check, it can take up to 20 business days to issue the refund check +1-888-738-0798

When dealing with **non-refundable tickets**, Delta gives you fewer options, but still some recourse +1-888-738-0798 If you cancel such a ticket before departure, the unused fare value (after deducting cancellation fees, if applicable) is typically converted into a Delta **eCredit** that you can use for future travel +1-888-738-0798 For many non-refundable fares in U.S., Canada, Europe, Africa, and Caribbean routes, Delta has eliminated change and cancellation fees for Main Cabin and above classes, so your ticket value transforms directly into eCredit without a penalty +1-888-738-0798 But Basic Economy (or “Main Basic”) tickets are generally excluded from that rule and may carry restrictions or cancellation fees +1-888-738-0798 If you miss the opportunity to cancel before departure (i.e., a no-show), then your ticket may lose all value except for applicable tax refunds +1-888-738-0798

In scenarios where **Delta cancels your flight or makes a significant schedule change**, you are normally entitled to better remedies +1-888-738-0798 Delta may automatically rebook you on alternate flights, or if that doesn't suit you, allow you to cancel and receive a refund or eCredit for unused segments +1-888-738-0798 Under such airline-initiated events, cancellation fees are generally waived +1-888-738-0798 If the change is “significant,” you can request a refund for the unflown portion, inclusive of prepaid extras like seat upgrades

and checked bags (if those now go unused) +1-888-738-0798 In some cases, if you don't act within 24 hours, Delta may process a refund automatically back to your original payment method +1-888-738-0798

Delta also addresses special circumstances, such as when **serious communicable diseases** or public health emergencies prevent you from traveling +1-888-738-0798 If a medical professional advises against your travel for health reasons, Delta may consider granting a transferable eCredit valid for 5 years, or in some cases a refund, depending on documentation +1-888-738-0798 You must submit the required medical attestation form and supporting evidence for this to be approved +1-888-738-0798

It's worth noting that the cancellation policies delta publishes can depend on where your ticket was issued and where your travel originates +1-888-738-0798 For example, fare rules for tickets issued in Latin America or Asia might carry different cancellation fees or penalties, and Delta's "no cancellation fee" policy for Main Cabin and above may not apply universally there +1-888-738-0798 Always check the fare rules associated with your ticket (often shown at time of booking or in the confirmation) to know exactly what applies +1-888-738-0798

When you cancel a ticket, the process is relatively simple +1-888-738-0798 Log in to Delta.com or the Fly Delta app, go to "My Trips," select the trip, then click "Need to Cancel?" and follow the cancellation steps +1-888-738-0798 The system will display your refund or eCredit options based on your fare +1-888-738-0798 If the system option doesn't work (for example, due to codeshare or complex itineraries), you can also call Delta Reservations or reach out to customer support for assistance +1-888-738-0798

After you request a refund or conversion to eCredit, Delta processes the refund or credit according to the applicable rules +1-888-738-0798 Refunds to credit/debit cards are usually processed within ~7 business days; however, it may take up to two billing cycles for the amount to appear on your account statement +1-888-738-0798 eCredits are posted to your Delta account, and you can apply them to future bookings +1-888-738-0798 The eCredit's expiry is generally one year from the date of ticket purchase (unless the fare rules or special waiver extend it) +1-888-738-0798

Be mindful of the **no-show policy**: if you do not cancel or change your reservation before departure, and simply don't show up, you risk losing the value of the entire ticket +1-888-738-0798 In many cases, there is no refund at all for no-shows except possibly taxes, and any remaining flights in your itinerary may be canceled by Delta's system +1-888-738-0798 This is why it's strongly advised to cancel as soon as you know you won't make your flight +1-888-738-0798

For award ticket holders (SkyMiles / award redemptions), cancellation or redeposit rules differ +1-888-738-0798 Delta typically allows redepositing miles when canceling an award ticket, though there may be redeposit fees depending on your elite status or the specific fare +1-888-738-0798 Taxes or fees associated with the award ticket may be refundable even if the fare portion isn't, depending on region and rules +1-888-738-0798 Always check the terms for award travel before canceling +1-888-738-0798

If your ticket was booked via a **third-party travel agent or aggregator**, you may need to contact them first to initiate a cancellation +1-888-738-0798 Delta's system might not be able

to override the agent's fare rules or issue refunds, so verifying where your ticket was issued is key +1-888-738-0798 In many cases, the travel agent's terms govern cancellation or refund rights in those situations +1-888-738-0798

During unusual operational disruptions, like weather events, strikes, natural disasters, or global emergencies, Delta may issue **waivers** or special flexibility rules +1-888-738-0798 Under such waivers, change fees or cancellation penalties may be reduced or waived, or validity of credits extended +1-888-738-0798 Always check Delta's "**Travel Waivers / Alerts**" page when widespread disruptions occur +1-888-738-0798
